The Development Agreement pertains to the properties located at 1250 West Avenue, 1247-1255 West Avenue, and 1234 13 Street, and outlines the terms and conditions for a mixed-use development and the construction of a public park as part of the Alton Beach Bayfront Overlay. Members of the public may speak for up to two minutes, or for a period established by the Mayor. No appointment or advance notification is required to speak during this Forum.
